Business:

- 1. The Board reviewed the agenda for tonight's meeting.
- 2. Public Comment 3 guests in attendance
 - a. No Public Comment
- 3. The Board reviewed the minutes from the Board meeting on June 28, 2023.
 - a. The Board did not have a quorum of Board members present tonight who were also at the last meeting. The Board will review and approve the minutes from June 28 at the next meeting.
